

Santa Rosa EMDR Group Consultation Agreement

This agreement is between Andrew M. Leeds, Ph.D. (Consultant) and _____
(Consultee).

Nature of Service: Specific learning objectives include perceptual, conceptual, and procedural skills involving the theoretical, practical and technical application of the AIP model and EMDR as a method of psychotherapy. **If Consultee's intention is to meet the consultation requirement for EMDRIA Certification in EMDR**, the focus will be on mastery of the **standard EMDR protocols** as described in Shapiro's 2001 text and Leeds 2016 text. EMDR case formulation and treatment planning skills will also be addressed. Screening procedures and issues of differential diagnosis for dissociative disorders may also be addressed; however, Consultee agrees that *modified EMDR treatment protocols* required for applying EMDR treatment to those with personality or dissociative disorders *if addressed will not be counted toward EMDRIA Certification hours*.

Limits of Service: It is expressly agreed that no supervision or employment relationship exists between Consultant and Consultee. Consultee – or Consultee's legally mandated supervisor if any – remains solely responsible for services provided to Consultee's clients. Consultant will provide information based on research, scholarly consensus, and Consultant's experience for Consultee to consider. Consultee will at all times rely on his or her own judgment in offering specific psychotherapy services to Consultee's clients.

Confidentiality: Consultee will notify his or her clients and obtain written informed consent prior to presenting any confidential case material to Consultant. Consultee will take all necessary steps to avoid disclosing any identifying information about clients verbally or in writing to Consultant.

Evidence of fidelity in the use of EMDR: It is agreed that before Consultant writes a letter in support of Consultee's application for EMDRIA certification, Consultee will provide Consultant with video or near verbatim transcripts of two or more EMDR treatment sessions and two or more case summary forms demonstrating satisfactory fidelity to standard EMDR principles, procedures and protocols. It is preferable for at least one such videotape or transcript to be presented to Consultant before the fifth hour of consultation.

Fees: While a member of the Santa Rosa group, Consultee agrees to pay Consultant his or her pro-rata share of Consultant's fee of \$160 per hour of service even if missing a scheduled meeting due to illness or vacation. Meetings are generally the first (occasionally the second) Thursday of the month 8:30 – 10:00 AM. Payment may be by check (preferred) or by credit card.

Resolution of issues: Consultant and Consultee agree to abide by their respective professional organizations' code of ethics. If any ethical issues arise related to the consultation relationship, Consultant and Consultee will make every effort to resolve them informally and with good will.
